- PAN Card of owner/firm
- Address proof of business (electricity bill/rent agreement)
- ID proof (Aadhaar, Voter ID)
- Business registration proof (if any)

A Shop Establishment Certificate, also known as a Shop Registration Certificate, which validates your store or office as a registered business.

### 2. Liquor License (Essential for Bars, Pubs, and Liquor Retailers)

Planning to open a bar, pub, or wine shop? You must obtain a <u>Liquor License</u> from the state excise department. Without it, selling alcohol is illegal and punishable under law.

#### Types of Liquor Licenses:

- Retail Liquor Store License (to sell sealed bottles)
- On-site Consumption License (for bars and restaurants)
- Club/Private Party Licenses (for restricted venues)

#### Apply Smart:

Today, many states offer Liquor License Online application systems, making the process simpler than ever. You can visit your state excise department's official website and apply from the comfort of your office or home.

#### Documents Required:

- Shop Establishment Certificate
- Address & ID proof
- Business PAN card
- NOC from fire department and local police
- Premises plan/layout
- Proof of ownership or rental agreement

Tip: Apply for your shop and establishment license first. It's often required when applying for your liquor store license.



#### Combined Licensing Strategy

For bars and liquor stores, both licenses are equally important. Skipping either one can result in heavy penalties or forced closure.

Here's a quick strategy to follow:

- 1. Register your business name (if not already done)
- 2. Apply for the Shop and Establishment License
- 3. Once approved, begin the liquor license online application
- 4. Simultaneously work on other licenses (FSSAI, GST, Fire NOC) as needed

#### Avoid These Common Mistakes:

- Running your business without a valid shop registration certificate
- Selling liquor before the liquor store license is issued
- Ignoring local laws or municipal rules regarding operating hours
- Not renewing licenses annually
